Qualified candidates will be an existing Northwestern faculty member (regardless of faculty track or degree, i.e., PhD, DrPH, EdD, MD, JD) with a track record of engagement in bioethics and medical humanities education, scholarship, and clinical work (e.g., bioethics consultation, educational programming in bioethics, empirical bioethics work), an interest in working with a diverse community of faculty/staff/students, and a strong interdisciplinary orientation.
